From Controller General's Desk

R.K. Sinha

The year 2015-16 witnessed several key reforms in the mineral sector. The IBM under the guidance of the Mines Ministry is involved in rolling out new initiatives by way of penetrating of new technologies for administering mines and minerals in the country. We have embarked on an ambitious plan to set up Remote Sensing Laboratory in the Bureau for the monitoring of mining activities using time series high resolution satellite imagery as part of an MoU signed between National Remote Sensing Centre (NRSC) of ISRO on Jan 21, 2016 at Hyderabad. In keeping pace with the smart governance, IBM will develop an ebook and a mobile app for filing of online returns under Rule 45 of MCDR 1988. A system of rating of mines based on the SDF parameters will be established. The completion of Mining Tenement System will provide a boost to use of IT and new technologies in the mines sector. We shall soon have presence at Raipur and Gandhinagar which will bring about more efficient delivery of our services to the mines sector in the states of Chhattisgarh & Gujarat respectively. An Interdepartmental Regional Committee at Regional office level and an Apex Committee at the Headquarter level are constituted to fast-track the evaluation of mineral blocks to be taken up for exploration.

Our office made immense stride in developing mechanism for monitoring important issues of which the Apex Committee for mineral concession references is a key among many others. The efforts taken to carry forward the reforms process has begun to show positive results in terms of mineral production. The index of mineral production of mining and quarrying sector for the month of March (2004-05=100) 2016 at 148.8 was 0.1% lower as compared to March 2015. The cumulative growth for the period April 2015-March 2016 as against corresponding period previous year stands at (+) 2.2%. The production of important minerals that showed positive growth during March 2016 over March 2015 include: Iron Ore (40.2%), Magnesite (32.9%), Copper Conc. (28.6%) Lead Conc. (20.2%), Gold (19.5%), Chromite (13.5%), Bauxite (11.9%), Diamond (11.6%) and Limestone (10.1%). The allowing of FDI up to 100% in exploration, mining, minerals processing and metallurgy under the automatic route for all non-fuel and non-atomic minerals including diamonds and precious stones and the amendment brought to MMDR Act, 1957 will further the growth story in coming days. I believe when the Bureau celebrates 70th Foundation Day next year, the mining industry will be poised for a robust growth owing to another round of slew of reforms in the pipeline.

Stock Taking Additional Secretary (Mines) visits Goa

With an objective to find a way out for the dumping of mine wastes, Shri R. Sridharan, Additional Secretary (Mines) visited Goa on 8 Jan, 2016 and held wide ranging discussions with the stakeholders. The waste handling became a vexed issue following the Supreme Court judgement of 21st April 2014 on W.P. (Civil) 435 of 2012 and the MMDR Act and Rules thereunder which bans the dumping of the mineral waste outside the mining lease area.

During his visit, Shri Sridharan visited the Advalpal Iron Ore Mines of M/s Lithoferro and Bicholim Iron Ore Mines of M/s Vedanta Ltd to get a sense of the enormity of the problem. He examined the field problems of dumping of overburden and mine owners' challenges.

The Additional Secretary called on Chief Minister of Goa, Shri Laxmikant Parsekar and held interactions with Shri R.K. Srivastava, Chief Secretary, Goa and Shri Amjad Tak, Secretary (Mines), Goa, Shri Prasanna Acharya, Director of Department of Mines & Geology of Goa. Dr. Y.G. Kale, RCOM, Goa and other officials accompanied the Secretary to the mines. A delegation from Goa Minerals Ore Exporters' Association (GMOEA) also called on Shri Sridharan and discussed the various issues facing the Goan Mining industry.

The Mining leases in Goa (erstwhile Mining Concessions) were granted by the erstwhile Portuguese Government before December 1961, when Goa annexed to Indian Republic. These leases were small in area and fragmented, and leased to different lease holders contiguous to each other.

The maximum area of lease granted was of 100 ha. As most of the working leases were fully mineralised it left little scope for dump wastes or over burden within leased area. Therefore, as per the traditional practice, the waste materials were dumped outside the mining lease area after due permission from the State Government. The visit of the Secretary intended to explore possible amendments to MMDR Act, 1957. Shri R.K. Sinha who served as the Controller General In-charge took full time charge of the office on April 1, 2016. Shri Sinha has three decades of experience in administration of mines and mineral legislations and brings his rich expertise for the service of the Bureau.

R.K. Sinha is Controller General

A fellow member of various professional bodies like Institute of Engineers, Mining Engineers' Association and MGMI, Shri Sinha has actively associated in framing guidelines for Mining Plan/Scheme of Mining and issuance of circulars and notices. He obtained his B. Tech (Hons.) in Mining Engineering from Indian School of Mines, Dhanbad in 1979 and worked with the Coal Mining Industry for a brief period. Shri Sinha joined the IBM as Assistant Controller of Mines and soon rose to Regional Controller of Mines for Southern and Central zones.

Shri Sinha is credited to with initiating the observance of ME&MC week in mines of South Rajasthan; reviewing the recommendations of NMP 2008 as a member of the Reviewing Committee; evolving environmental standards for Ministry of Environment, Forest and Climate Change and was nominated as expert member on the committee to evolve model guidelines on Environmental aspects of

"An estimated ₹ 6000 crores is expected to accrue into the District Mineral Fund and there are District Mineral Foundation formed at every district collectorate and it will look into the developmental requirements of the area," he said adding that more research was required to develop the mining field in country. Later, the Minister presented trophies to the RCOM, Bhubaneshwar and Hyderabad offices for their outstanding contribution towards creating awareness about online return among mine owners.

The Union Minister of Tribal Affairs Shri Jual Oram commended the role of IBM in bringing discipline in the Mining sector and said the amended MMDR Act would bring transperancy. Union Minister Shri Dharmendra Pradhan asked IBM to educate mining fraternity about the legal framework of mining leases and allotment process. While, Shri Prafulla Kumar Mallik stressed for a sustainable effort to create forests before commencement of mining operations. The Government of Odisha had resolved to plant at least 10 lakh trees per year, he reiterated.

Policy Direction Sustainable Development framework for mining sector soon

n accordance with the policy direction in the National Mineral Policy, 2008, the Ministry of Mines has entrusted M/s ERM India Pvt. Ltd to develop a Sustainable Development Framework for the mining sector (Non-coal, Non Fuel) in India.

The SDF was rolled out for the first time in Sukinda Chromite mines of M/s Tisco in Odisha on 7 Jan 2016 and at Donimali Mines of the NMDC at Bengaluru in the presence of Secretary (Mines) Shri Balvinder Kumar and then Controller General In-charge Shri R.K. Sinha. An institutional system, the proposed SDF would be fully intergrated through an arrangement of representative cells, though functioning at different levels.

The framework would bring out specific functions linked to different levels like National level, State level at the Mining Regional level and the Lease level.

If the Ministry of Mines and the DMGs will function at National and State level respectively, strategic decision for mining, environment, social safeguards and infrastructure development would be taken up at Mining Regional level.

At the lease level, each mine would have an organisational structure in place to manage sustainable development performance.

The IBM is in the process of developing Online System of Star Rating for the mines based on SDF parameters.

In this process, the miners on their own would fill up the details with the help of mobile app to be launched for rating purpose.

IBM signs MoU with NRSC for Sudoor Drishti

n a new milestone, the Indian Bureau of Mines has entered into a Memorandum of Understanding (MoU) with National Remote Sensing Centre (NRSC), Department of Space for project "Sudoor Drishti" – for monitoring mining activity through satellite image under Digitial India programme.

Shri R.K. Sinha, then Controller General In-charge and Shri P.G. Diwakar, Deputy Director, NRSC signed the MoU on 21 Jan 2016 at Hyderabad. Shri Subhash Chandra, Joint Secretary (Mines), Shri Girija Shankar, Principal Secretary, Department of Industries and Commerce, Telangana State and senior officials of IBM and state government, heads of mining industry were present on the occasion.

Apart from monitoring core mining

activities, the project can also be used by the State Governments for various purposes such as detection and monitoring of illegal mining, material movement and revenue collection from minerals etc. It can also be used as an efficient tool for sustainable mining and keep an eye on reclamation and rehabilitiation, social footprints, water bodies and agriculture, tribal tracts, sanctuaries and bio diversity zone and mining clusters.

According to the MoU, NRSC shall impart training to the IBM officials in processing and interpretation of satellite data. It would also provide technical guidance in creating a remote sensing cell at remote sensing unit at IBM, Nagpur and Hyderabad.

Bhuvan based services shall be used for monitoring of mining activities and

development of mobile app for field data collection to verify the ground realities with respect to the approved proposals. NRSC shall also carry out a pilot project to demonstrate the feasibility of using High Resolution Satelite Imagery in monitoring mining activities over a period of time, over select group of mines identified by IBM.

This includes checking and validation of the consistency of Differential Geo Positioning System (DGPS) points collected as a part of lease boundary survey programme of those mines. As a R & D effort, volume changes in the select group of mines using satellite derived DSM will also be attempted. The Limestone mining in Tandur region of Telangana State and Bellary-Hospet region for iron ore in Karnataka have been identified for this purpose.

The Mining Policy Round Table with Government of Goa held on 5 March, 2016 at Goa engaged in a fruitful discussion on restoring the glory of mining sector through sustainable development and trusted partnership between the Government and the mining industry.

The Federation of Indian Chamber of Commerce and Industry (FICCI) organised the Round Table with a view to give a fillip to the mining activity in the state. Shri Laxmikant Parsekar, Hon'ble Chief Minister of Goa inaugurated the Round Table. Balvinder Kumar, Secretary (Mines) Government of India, Shri R.K. Srivastava, Chief Secretary, Goa attended the inaugural session.

In his inaugural address, Shri Parsekar said the Centre and State Government made all efforts to ensure mining activity resumed in Goa and became financially sustainable. The mining sector in Goa was undergoing metamorphism with new vision, renewed energy and procedures to contribute to the economic development and creation of employment. "The State taxes are being rationalised in line with market trends and for making an enabling environment," he said.

Shri Balvinder Kumar, in his address highlighted the salient features of MMDR Amendment Act, 2015 like District Mineral Fund, National Mineral Exploration Trust and grant of Mining Concession through auction. He cited the successful auctioning of mineral blocks in various parts of the country and added that the finalisation of National Mineral Exploration Policy (NMEP) would give a boost to the Mining Industry.

Later, while presiding a session, he urged the industries to adopt Sustainable Development Framework for self-certification. "The State may prepare an infrastructure plan and the mining industries should support it. The State must gear up for e-auctioning of mineral blocks whose lease period expires," he said.

Shri R.K. Srivastava, Chief Secretary of Goa said the closure of mining activity in Goa in the last few years badly affected the Goan economy. "There is every effort to revive. The industry must resume mining in a sustainable way," he appealed. During the second session chaired by Shri Balvinder Kumar, Dr. Y.G.Kale, Regional Controller of Mines, presented a paper on the theme, "Impact of Amended MMDR Act-2015 on Goan Mining Industry". He enumerated the important provisions of amended MMDR Act 2015. He also spoke on dumping of waste, lifting of e-auctioned ore, rationalisation of royalty, tax structure and possible solutions for vexed issues.

Earlier, Dr. Arvind Prasad, Director General, FICCI said the mining industry was key supplier of raw materials to the core sector industries. The Goan mining industry plays a key role in the economic development of the State and the country, he said.

Shri Amber Timblo, Secretary, Goa Mineral Ore Exporters' Association spoke about the Round Table and the challenges before Goan Mining Industry. Shri A.N.Joshi, Member, Mining Committee FICCI gave vote of thanks.

Raw material security for Steel Industry emphasised

A Conference, "Raw Materials Security for Iron and Steel" was organised to lay a detailed roadmap for the seamless supply of raw materials for the Iron and Steel Industry at Goa on 6-7 November, 2015. Indian Bureau of Mines actively took part in the two day conference organised by the Federation of Indian Mineral Industries (FIMI).

The Union Minister of State for Mines and Steel Shri Vishnu Deo Sai inaugurated the conference. He informed that the Government is in the process of initiating necessary steps to meet the envisaged target of 300 million tonnes of steel production by 2025. The MMDR Amendment 2015 provides for allotment of resources allocation on auction basis. The Central Government was working with state governments to ensure early auction of iron ore leases. The States of Karnataka and Odisha were in the advance stage of auction. The private sector should play a crucial role in ensuring and enhancing raw material security for iron and steel industries. The proposed National Minerals Exploration Trust would accelerate the exploration activities, he said.

Shri R.K. Sinha, Controller General (I/c), IBM, Shri S. Tiu, Controller of Mines (SZ), Dr. Y.G. Kale, RCOM, IBM Goa participated in the conference as special invitees. Besides, Shri G.K. Jangid, DCOM, Shri M.K. Kalmata, SMG, Shri G. Ram, ACOM, Shri G.S. Kannan, JMG and other officials of IBM Goa office also participated. Dr. Y.G. Kale presented a paper titled, "Goan Iron Ore Mining: Present Status and Way Forward" jointly authored by Dr. Kale, Shri S. Tiu and Shri R.K. Sinha. Shri R.K. Sinha presented the introductory remarks of the paper giving a national scenario of iron ore reserve & resource, production details and statistics. Shri Sinha also chaired a technical session on "Growth path for Indian Mining Sector, Policy Initiatives and Mechanism of its Implementation". While, Dr. Kale highlighted the various concerns which are critical for smooth resumption of mining activity and possible solutions.

Notification IBM's Charter of Functions revised

The Government has modified the Charter of Functions vide Resolution No. 31/49/2014-M.III, dated 3.11.2014 and notified in the Gazette of India on 22.11.2014, taking into account the draft suggested by the Committee. The New Charter of Functions are: The IBM shall

- 1. Collect, Collate and organise into a database, all information on exploration, prospecting, mines and minerals in the country in the shape of National Mineral Information Repository and take steps to publish and disseminate the same;
- Function as the National Technical Regulator in respect of the mining sector, and lay down regulations, procedures and systems to guide the State Governments (first tier of regulation);
- Build up capacity in the system, both for regulatory as well as the developmental work, at the central level as well as at the level of the States;
- Establish institutional mechanisms of coordination between the centre, the States, mineral industry, research and a c a d e mic institutions and all stakeholders, so as to proactively develop solutions to the demands and problems faced by the industry;
- 5. Promote research on all aspects of practical relevance to the Industry and to act as bridge between research institutions on the one hand and user industry on the other;
- 6. Provide Technical Consultancy Services;
- 7. Participate in international collaborative projects in the area of regulation and development of the mineral sector;
- 8. Advise Government on all matters relating to the mineral industry; and
- 9. Undertake any such other activity as has become necessary in the light of developments in the field of geology, mining, mineral beneficiation and the environment.

Technical Updates

Bench Scale Beneficiation Study on Rejects of Manganese Ore

The black dump rejects from Ukwa mine of M/s MOIL was received at Modern Mineral Processing Laboratory and Pilot Plant, IBM, Nagpur for conducting bench scale beneficiation studies. The objective of the investigation was to develop a process flow sheet to produce manganese concentrate suitable for end-user industry.

The as received sample assayed 8.02% Mn, 2.61 % Fe (T), 75.41 % SiO₂, 2.63% Al₂O₃, 0.68 % CaO, 0.23% MgO, 0.61% BaO, 1.03% Na2O, 0.53% K₂O, 0.13% P, 0.02% TiO₂,

Recovery of Silica Sand from Katangjhri Manganese Ore mine

The Mineral Processing Division of IBM has developed a process on the overburden of Katangjhri Manganese Ore mine to recover silica sand as a value added product to be used as stoving material in the Katangjhri Manganese ore mine, Balaghat, Madhya Pradesh. Thus, the process developed by M.P. Division of IBM has an achievement to convert the overburden into value added product.



0.04% Sr0, 0.2% S(T) and 1.26% LOI.

Gravity concentration by employing tabling at -65 mesh size followed by wet high intensity magnetic separation at 12000 Kilo Gauss of table tails yielded a composite manganese concentrate with a reasonably good grade and recovery. The composite concentrate obtained by combining the table concentrate and magnetic fraction of table tails assayed 30.08% Mn, 7.76% Fe (T), 29.42% SiO₂, 2.62% Al₂O₃, 0.21 % P, and 3.1% LOI with a Mn recovery of 72.2% (Wt% yield: 18.4). The Mn to Fe ratio is 3.87.

The sample is amenable for beneficiation by gravity cum wet magnetic



separation. The fine concentrate obtained may find utilisation in Steel Industry after agglomeration.

Blast induced vibration study of Kovaya Limestone Mines

The Mining Research Cell of the TMP Division of Indian Bureau of Mines carried out a study of ground vibrations due to blasting at their Kovaya Limestone Mine, Rajula Tehsil, Amreli District in Gujarat. On a request from M/s Ultratech Cements Ltd, Gujarat Cement Works, the IBM carried out the study over a lease area of 959.325 ha near Kovaya village, to study the impact of blast induced ground vibrations on the nearby structures, human settlements and to suggest control measures to minimise the adverse impact. Under the study, a total nine experimental blasts at different benches were conducted with varying charge pattern and total 26 blast events were recorded and monitored at three different locations simultaneously for each blast.

Based on the monitoring, a data and regression analysis report has been prepared and submitted to the party. During the study, the maximum peak particle velocity observed as 19.81 mm/sec at a distance of only 93 m from blast site with maximum charge per delay of 48 kg and total explosive charge of The maximum peak particle velocity observed as 19.81 mm/sec at a distance of only 93 m from blast site with maximum charge per delay of 48 kg and total explosive charge of 2304 kg, which is far below the safe limit

2304 kg, which is far below the safe limit. The frequencies observed are in the DGMS prescribed range of 3 Hz to 100 Hz. The dominant frequency of ground vibration resulting from the blasting are < 8 Hz is 8 %, 8 to 25 Hz is 74 % and > 25 Hz is 18%. As the frequencies observed below 8 Hz are only 8 %, it poses no threat or danger to the nearby structures. The peak air over pressure (sound level) due to blasting varies from 100 to 136.7 dB (L). The recorded data is well within the safe limit as far as the structures are concerned. For minimising vibrations effects and fly rocks, control measures have been suggested in the report.

Registration under Rule 45 of MCDR

The registration under Rule 45 of MCDR, 1988 has made good progress. Out of the 4414 working leases, 4341 leases have registered under the amended Rule 45 as on March, 2016. While, 4367 leases out of the 5416 non-working leases are registered. In total, 8708 leases are registered with the IBM. About 972 mines/leases are suspended. About 678 mines/leases are recommended to the state government for termination. Also, 10,587 end-users, traders, stockiest and exporters are registered so far.

MM leasehold maps

The Geological Mapping & Mineral Map Cell has taken up the Scanning & vectorisation of tophosheets for Andhra Pradesh (un-divided). The GM Cell will also take up geo-referencing and cropping of regional geology, scanning of ML plans, plotting of ML on toposheets and preparation of forest overlays. While, the creation of map-based mine data, finalisation and validation of cartographic map work are also completed. Simlarly, scanning of 11 tophosheets, vectorisaton of 8 toposheets, geo-referencing and cropping of regional geology for 86 tophosheets, scanning of 275 ML plans and plotting of ML on 240 toposheets have been completed. While, for Kerala, scanning of 2 toposheets, vectorisation of 2 toposheets and plotting of ML on 11 toposheets is completed.

Also, a scheme on 'Mining Tenement System' with the objective to develop an online National Mineral Information System for investors by linking the Central and State organisations engaged in administration of mineral resources in the country is also under implementation.

Progress Report Project on Mining Tenement System

The new draft RFP, after incorporation suggestions of the industry participants was finalised 22 Dec, 2014. Following several

deliberations, the bids were opened on 20th Jan, 2016 in presence of representative of bidders. M/s Wipro, TCS and L&T have submitted their bids. Bids were forwarded to E & Y, the consultant for processing, technical evaluation and preparing the preliminary report which to be reviewed by the TEC. M/s E & Y furnished draft observations on prequalification bids on 23.2.2016 for further review of TEC.

The TEC after review sought clarifications from bidders. The second meeting of the TEC was held on 28 March, 2016 through video conferencing to analyse adequacy of clarification documents submitted. The evaluation process is continued.


दक्षिणी राजस्थान में 16 वां खान पर्यावरण एवं खनिज संरक्षण सप्ताह सफल

बेंगलूर क्षेत्रीय कार्यालय


