Subject: Violation of provisions of MCDR, 1988 in respect of your Kandali Vermiculite Mine in Nellore District, A.P. State over an extent of 3.844 ha.

Sir,

The following provisions of Mineral Conservation and Development Rules 1988, were found violated in your above mine during inspection on 13.04.2013 by Shri A.V.Ramesh Kumar, Assistant Mining Geologist. IBM, Hyderabad office accompanied by Sri B.Koteswara Rao, Lessee.

Rule No.	Nature of Violation
45(5)(a)(viii)	Monthly returns in Form F-8, have not been submitted from February 2013 onwards to the Regional Controller of Mines, IBM, Hyderabad so far as required under this rule.

02. It is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provision of Rule 45(5)(a)(viii) is also liable for suspension of mining operations under rule 45(7)(i)(a) of MCDR, 1988.

03. You are, therefore, directed to **show-cause** within a period of 30(thirty) days from the date of issue of this letter, as to why you should not be **prosecuted** for the above offence and or Mining operations shall be suspended under the provision of Rule 45(7)(i)(a) of MCDR,1988 in the Mine till the compliance of the aforesaid violation.

04. Please note that no further notice will be given to you in this regard.
