Subject : Violation of provisions of Mineral Conservation and development Rules, 1988 in respect of your **Keshra Bauxite Mine** over an area of 4.9 Hect. in Sarguja district of Chhattisgarh State.

Sir,

During the inspection of your Keshra Bauxite Mine (4.9 ha) on 26.09.2013 by the undersigned, the following provisions of Mineral Conservation and Development Rules, 1988 is found violated in respect of your mine :-

Rule No. of MCDR, 1988	Nature of violations observed
13(1)	<p>Every holder of a mining lease shall carry out mining operations in accordance with the approved Mining Plan / Scheme of Mining with such conditions as may have been prescribed under sub-rule (2) of rule 9 or such modifications, if any, as permitted under rule 10 or the Mining Plan or Scheme of Mining approved under rule 11 or 12 as the case may be.</p> <p>It was observed during site inspection that in the lease area, 7.5 m of barrier zone has been excavated in the eastern part without any proposal in the Modified Mining Plan approved earlier vide letter No. SRG/BX/MPLN-928/NGP, dated 21/04/2009. Thus attracting the violation of rule 13(1) of MCDR'88, which may lead to suspension of mining operations in accordance to rule 13(2) of the MCDR'88.</p>

02. In this connection, it is brought to your notice that the above violation of said rule constitutes an offence punishable under Rule 58 of MCDR, 1988.
03. You are, therefore, advised to rectify the above violations **within 45 (forty five) days** from the date of issue of this letter, as to why mining operations in your above mine should not be suspended in accordance to rule 13(2) of MCDR, 1988 and the lease is recommended for termination as well as prosecution of the owner, agent and manager.
