Subject: Violation of provisions of Mineral Conservation and Development (Amendment) Rules, 1988 in respect of your **Maratha Limestone Mine** over an area of 49.0 Hect. in Chandrapur district of Maharashtra State.

Sir,

On examination of this office records, it is observed that the following provisions of Mineral Conservation and Development (Amendment) Rules, 1988 amended vide notification of GSR 75(E) dated 09.02.2011 are violated in respect of your above referred mine:

Rule	Nature of violations observed
23F3	The lessee shall submit the financial assurance to the Regional Controller of Mines or the officer authorised by the State Government in this behalf, as the case may be, before executing the mining lease deeds. In case of an existing mining lease, the lessee shall submit the financial assurance along with the progressive mine closure plan. <i>However, Financial Assurance submitted has already been expired on 31.03.2016 and no valid Financial Assurance is existing for the mine.</i> <i>Thus violation of Rule 23F3 has been observed. These violations may lead to suspension of all mining operations in the mine as well as termination of mining lease and prosecution of the owner, agent and manager.</i>

01. In this connection, it is brought to your notice that, the above violation of said rule constitutes an offence punishable under Rule 58 of MCDR, 1988.

02. You are, therefore, **advised to rectify the above violation immediately and intimate the position to this office within 45 days** from the receipt of this letter.

Please note that no further notice will be given to you in this regard.
