COURSE REPORT

Two day workshop cum Training Programme on "Filing of Returns Under Rule 45 of MCDR 2017" for Industry persons from 15th to 16th July, 2019 held at Raipur Chhattisgarh.

A Two day Workshop-cum-Training Programme on "Filing of Returns under Rule 45 of MCDR 2017" for Industry persons under the jurisdiction of Central Zone IBM was organized from 15th to 16th July, 2019 at Raipur(Chhattisgarh) with objective to sensitize the personnels from mining and mineral industry by Regional Office, IBM, Raipur on behalf of Training Centre, IBM, Nagpur.

Shri D.R. Patel, Ex-Joint Director, Director of Geology and Mines, Government of Chhattisgarh, who was the Chief Guest of Inaugural Session, emphasized the need for systematic implementation and Submission of Monthly and Annual Returns. So far 90 executives of middle to senior management level from corporate, private companies including PSU's from the states of Chhattisgarh, Madhya Pradesh, Maharashtra, Odisha and Jharkhand actively participated.

The Training Programme comprised of seven sessions, covering thematic subjects on Statutory Provisions for Monthly & Annual Returns, their role in ASP estimations, Brief exposure on Mining Tenement System (MTS) enabling Registration & Online Submissions of Returns, general mistakes/deficiencies observed, referred back cases have been discussed in length citing exemplary cases. Further, registration and filling returns for traders, stockists, consumers and exporters was also covered wherein how data outputs are helpful in perusing sustainable production and consumption of minerals. S/Shri B.L. Gurjar, RCOM, IBM Raipur; Shri G.K. Jangid, RCOM, MTS; Miss Noushida N.A. Joint Director (S), and Shri M.K. Meena, AME(I) were faculties. Shri Rajesh Kumar Das, Senior ACOM and Shri Abhishek Gautam, AME were the Course director and the Course Coordinator respectively.

On the concluding day, Dr K. Rajeswara Rao, IAS, Additional Secretary and Controller General, Incharge, IBM interacted with few participants through teleconferencing. He expressed his concern about non submission/ incorrect submission and late submission of monthly and annual returns and its impact on publication of ASP of various minerals and royalties and stressed upon timely submission of returns.
