विषय – म0प्र0 राज्य के बालाघाट जिले में स्थित आपकी Chakaheti Manganese Ore खान (क्षेत्रफल 3.44हे0) में खनिज संरक्षण एवं विकास नियमावली, 2017 के नियमों का उल्लंघन।

महोदय,

Following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during the inspection of the mine by Shri P.Nahar, Asstt. Mining Geologist of this office on 25/04//2018 in presence of Shri N.K. Pashine,QP and Mr. Shri rangarao your representative-

नियम/धारा उल्लंघन के प्रकार का विस्तृत ब्यौरा

नियम 11(4)—According to this rule the holder of a mining lease shall submit the mining plan to the competent authority for review at least one hundred and eighty days before the expiry of five years period for which it was approved on the last occasion for mining operations for a period of five subsequent years.

The Scheme of Mining of above mentioned mine was approved vide this office letter no. BGT/MN/MPLN-1007/NGP dated 15/12/2014 incorporating proposals of working from 2011-12 to 2015-16. The period of above mentioned Mining Plan is expired on 31/03/2016. But Review of Mining Plan for subsequent five years period is not submitted to the competent authority i.e. Regional Controller of Mines, within stipulated time limit.

Thus there is a violation of above mentioned rule.

नियम28(1)-Subject to the provisions of Section 4A,the holder of a mining lease shall send to the authorized officer, as the case may be and the State Govt. a notice in Form-E when the mining or mineral processing operations in the mine or part thereof are discontinued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary discontinuance. But during the inspection it was found that the mine is closed for more than 90 days but notice of temporary discontinuance of the mine has not been not submitted in the prescribed Form-E.

नियम 45(5)(b)—According to this rule -the holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorized official of the Indian Bureau of Mines , a monthly return which shall be submitted before the tenth of every month in respect of the preceding month in electronic form along with a signed print of the same if it is not digitally signed .

During inspection it was found that Monthly Returns have not been submitted online since opening of the mine in the prescribed Form.

नियम 45(5)(c)—According to this rule -the holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorized official of the Indian Bureau of Mines , an annual return which shall be submitted before the 1st day of July each year for year for the preceding financial year in electronic form , along with a signed print copy of the same .

During inspection it was found that any Annual Return since opening of the mine has not been submitted online to the Regional Controller in prescribed form .

02 In this connection it is brought to your notice that the above violations constitute an

offence punishable under Rule 58 of MCDR-1988.

03 For non compliance of above rule 45(5)(b) and 45(5) (c) in case of mining of minerals by the holder of a mining lease, the Regional Controller of Mines may advise the State Govt. to take action as per rule 45(7)(a)(i)(ii) and(iii). Of MCDR-2017 and for non compliance of the rule 11(1) of MCDR-2017 the mining operations can be suspended under the provisions of rule 11(2) of MCDR-2017.

04 You are advised to rectify the above violations immediately and intimate the position to this office within 45(Forty Five) days from the date of issue of this letter.
