महोदय,

Following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during the inspection of the mine under Review of Mining Plan by Shri P. Nahar, Asstt. Mining Geologist of this office on 21/11/2018 in presence of Shri Rajesh Choubey , Mining Engineer and Shri N.K.Dixit ,Geologist-

नियम/धारा उल्लंघन के प्रकार का विस्तृत ब्यौरा

नियम 46—The holder of the mining lease shall-

- (a) when any new appointment of an agent, mining engineer, geologist or any person is made under sub-rule(1) of rule 55 or
(b) when the employment of any such person is terminated or any such person leaves the said employment or
(c) when any change occurs in the address of any such person within fifteen days from the date of such appointment, termination ,leaving or change in address give a notice in **Form-H** of the schedule to the authorized officer as the case may be.

During inspection it was found that notice of appointment of Shri Rajesh Kumar Choubey, as Mines Manager and Shri R.R. Prasad, as Mining Engineer have not been given to the Regional Controller of Mines in the prescribed Format within stipulated timeframe.

नियम55(3) —For the purpose of carrying out mining operations in accordance with these rules every holder of a mining lease shall employ ,in case of-

- i) Category A mines, a whole time mining engineer and geologist.
ii) Category B mines a part time mining engineer and a part time geologist.

Provided that in the case of fully mechanized category A mines the mining engineers and geologist shall have minimum five years of professional experience of working in a supervisory capacity in the field of mining. As per this office record above mentioned mine is a Category 'A' Mine but a whole time geologist has not been appointed.

Thus there is a contravention of above mentioned rules.

02 In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03 You are advised to rectify the above violations immediately and intimate the position to this office within 45(Forty Five) days from the date of issue of this letter.
