विषय/S u b: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your K. K. Kaval Iron Ore Mine (ML No. 2583) over an extent of 20.64 Ha in Kudurekanive Kaval village, Hosdurga Taluk, Chitradurga District, Karnataka state.

महोदया/ Madam,

The following provisions of the Mineral Conservation and Development Rules, 2017 read with Mineral Conservation and Development (Amendment) Rules, 2021 in your above mine during inspection on 24.07.2023 by Shri. Gangadhar Bhakat, AME in the presence of Sri. Basavaraj R, Mines Manager and other mine officials.

	As per the rule, every holder of a mining lease shall monitor
35(2)	his mining and allied activities as per the template of star
	rating in the format and shall submit online its self-
	assessment report before the 1st day of July every year for
	the previous financial year. The same has been submitted
	on 03.08.2023 which is 33 day late form the due date.
	Hence, you are liable to pay an amount of ten thousand
	rupees per day for such delay to the Indian Bureau of Mines
	under Sub-rule (4B) of Rule 35 of MCDR, 2017.
	In the Annual Return submitted for the year 2022-23,
45(7)	following discrepancies were observed:

- i. As per the provision of Rule 45(5)(c) " an Annual Return shall be submitted before the 1st day of every July each year for the preceding financial year in electronic form" for the year 2022-23 has been submitted on 07.07.2023 which is 06 days late from the due date of submission. Hence, you are liable to pay an amount of ten thousand rupees per day for such delay.
- ii. Part I (General) of AR: Excel sheet of PMCP table & UAV (KML/KMZ) files has not been uploaded.
- iii. Part II (Employment and Wages) of AR: No of supervisory staff employed at the mine have not been furnished.
- iv. Item-2 & 3 of Part V (General Geology & Mining): (a)The details of Mineral Reserves and Resources estimated for Iron ore at the end of the year under different UNFC codes are not reported correctly as per the last approved document after depleting the production from the Reserve part achieved subsequently upto 31/03/2023. The same may be rectified.(b)The Reserves and Resources estimated for Manganese Ore as on 01.04.2023 have not been furnished.
- v. Item-4 of Part V (General Geology & Mining): Overburden & Waste generated (in Cum.) during the year 2022-23 have not been furnished correctly.
- vi. Item-5 of Part V (General Geology & Mining): No's of Trees planted during the year 2022-23 have not been furnished.
- vii. As per part VI of the Annual Returns submitted for FY 2022-23, Ex-mine price have not been furnished correctly for lumps and fines.
- viii. As per the part VII of the Annual Returns submitted for FY 2022-23, the production proposal for financial year 2022-23 have not been reported.
- 02. The Mining operations and dispatches may be suspended and any action under sub-rule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.
- 03. The late submission of Star rating template fine amount under Rule 35(4B) of MCDR (Amendment), 2021 to be paid @ Rs. 10,000/per day i.e., Rs. 10,000/- x 33 days = Rs. 3,30,000/- (Rupees Three Lakh Thirty thousand only). The said penalty is to be paid through https:/bharathkosh.gov.in web portal under the purpose head "Non filing of Star Rating Template" in favour of "137321 Regional Controller of Mines, IBM Bangalore".
- 04. The late submission of Annual Return fine amount under Rule 45(7) of MCDR (Amendment), 2021 to be paid @ Rs. 10,000/- per

day i.e., Rs. 10,000/- x 6 days = Rs, 60,000/- (Rupees Sixty thousand only). The said penalty is to be paid through https:/bharathkosh.gov.in web portal under the purpose head "Non submission/faulty Monthly Returns" in favour of "137321 - Regional Controller of Mines, IBM Bangalore".

- 05. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 06. You are, therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under sub rule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.
- 09. You are herewith given **30 days**-time for reply and rectification of the violation from the date of issue of this notice. Please note that no further notice will be given to you in this regard.
