The following provision of Mineral Conservation & Development Rules, 2017 was found violated during inspection your above said mine on **29/9/2023** by Shri Prashant S. Hedge, Regional Mining Geologist of this office in presence of S/Shri Manoj Kumar, Mines Manager, Sushil Kumar Gond, Mining Engineer, Amrit Kumar Behera, Geologist, Pradeept Mohapatra, QP and other mine officials.

Rule No.	Nature of violation observed
45(7)	On examination of submitted Annual Return of FY 2022-23, it is found to be in-complete/wrong as furnished below. i)Item No. 12 of Part-I: The information furnished related to the actual lease area (surface area) utilization as at the end of year was not matching as compare to submitted draft modified RMP on 13/09/2023 and land-use map submitted along with DAI under rule 34A. ii)Approved production proposals has not been entered/submitted/updated so far.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. You are advised to **rectify the above violation immediately** and **intimate the position to this office within 45 (forty five) days** from the date of issue of this letter.
