### CIRCULAR

One post of Junior Mechanical Engineer in the Pay Level-10 (Rs. 56100-177500/-) is vacant in Indian Bureau of Mines under the Ministry of Mines and is to be filled up by deputation including short term contract basis.

- O2. The Junior Mechanical Engineer is responsible for scrutiny and finalization of Engineering Drawings pertaining to Mineral processing equipment's, layout design drawings and foundation drawings, dismantling of existing Pilot Plant equipment's, reassemble, installations and commissioning of various equipment's including those of air-conditioning, ventilation, dust and fume exhaust/control system to conducting Integrated Geological Studies for appraisal of mineral deposits and also to undertake MCDR inspection of mines in any part of the country and abroad. Conducting technoeconomic feasibility studies and scrutiny of mining plan/mining schemes and examination of stopping proposals, and environmental studies. Periodic updation of National Mineral Inventory of leasehold areas. Guiding and supervision the work of such officers who are placed under him.
- 03. As per the Recruitment Rules for the post of Junior Mechanical Engineer, the candidate to be considered for appointment by deputation including short term contract from the officers under the Central Government or State Governments or Union Territories or Universities or recognised research institutions or public sector undertakings or statutory organizations or autonomous bodies.
  - (a)(i) holding analogous posts on regular basis in the parent cadre or department; or
  - (ii) with two years service in the grade rendered after appointment thereto on regular basis in posts in Level-9 in the pay matrix (Rs. 53100-167800) or level-8 in the pay matrix (Rs. 47600-151100), and
  - (b) possessing the educational qualifications and experience:
  - (i) Essential Qualification: Bachelors Degree in Mechanical Engineering from a recognised University or institution or equivalent.
  - (ii) Experience: Three years experience in mechanical repairs, maintenance, installation and commissioning of equipment preferably in mineral processing plants.

**Note-1:-** The departmental officers in the feeder grade who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

**Note-2:-** The Period of deputation including the period of deputation in another excadre post held immediately preceding this appointment in the same or some other organization or department of Central Government shall ordinarily not exceed three years.

**Note-3:** The maximum age-limit for appointment by deputation shall be not exceeding fifty-six years as on the closing date of receipt of applications.

- 04. The deputation period will be initially for 03 years and will be considered for further extension on the basis of requirement of this department and NOC from the parent department. However, the officer may also consider for pre-mature revision to the parent cadre by serving 03 months advance notice to the parent department as well as to the officer in terms of provisions contained under DOPT OM No.6/8/2009-Estt. (Pay II) dated 17.06.2010.
- O5. Application containing the bio-data (in triplicate) of the official who fulfills the above as on the closing date may be sent through proper channel addressed to The Controller of Mines (P&C), 2nd Floor, Indian Bureau of Mines, Indira Bhavan, Civil Lines, Nagpur 440 001 in the enclosed bio-data proforma (Annexure-I) within 60 days from the date of publication of advertisement in the Employment News alongwith the up-to-date Confidential Reports/Dossiers for the preceding 05 years, Integrity Certificate, Vigilance Clearance and No penalty certificate for preceding 10 years of the official concerned. Applications received after the closing date will not be entertained. Also, advance copies of applications or not accompanied with all the above certificates/enclosures are liable to be rejected.

06. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
