The following provisions of the Mineral Conservation and Development Rules, 2017 read with Mineral Conservation and Development (Amendment) Rules, 2021 in your above mine during inspection on 13.10.2023 by Shri. Gangadhar Bhakat, AME in the presence of Sri. Jeelan, Mines Manager and other mine officials.

Rule	Nature of violations observed.
11(1)	The Mining operations are required to be carried out in accordance with the approved Review and Updation of Mining Plan document vide letter no. 279/591/97/BNG dated 24/11/2020, However, during the site inspection, deviations were observed in mining operation vis-à-vis approved document and are as follows:
	For the Year 2022-23, It was proposed to carry out Development work with 90,032 Tonnes of waste generation. However, Development is carried out generating only 5,040 Tonnes of waste during the year deviating from the proposed

quantities and not achieving the proposed stripping ratio.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 03. The violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
- 04. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
