The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 26.12.2023 by Sri Ganagadhar Bhakat, AME in the presence of Sri Narayana Rao, Agent, Shri Ashok Kumar, Mines Manager/ Mining Engineer.

Rules	Nature of Violations observed
45(7)	The online Annual Return for the year 2022-23 has been submitted by the lessee, following discrepancies were observed during the inspection: i. As per part –V 1. of Annual Returns submitted for FY 2022-23, the earlier exploration details have not been incorporated in the table. ii. Item-2 of Part – V (General Geology & Mining): The details of Mineral Reserves and Resources estimated for Magnesite at the end of the year has not reported correctly as per the last approved document after depleting the production from the Reserve part achieved subsequently up to 31/03/2023. The

same may be rectified.

- 02. The Mining operations and dispatches may be suspended and any action under sub-rule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.
- 03. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 04. You are therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under subrule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.
- 05. You are herewith given 30 days time for reply and rectification of the violation from the date of issue of this notice.
