All commercial activities with respect to IRS satellite data and products would be handled by NSIL. Bhoonidhi will continue to be the data dissemination platform.

1. HOW ARE THE USERS CATEGORIZED?

User are categorized under following 3 categories:

- Government Entities (GE) – Government Entities (GE): Following declaration form ([GE Declaration Form](#)) is to be submitted to data@nrsc.gov.in for Indian government users to declare status as GE
- Non-Government Entities (GE) – All Indian users other than GE are tagged as NGE users.
- Foreign Entities (FE) – All non-Indian users are tagged as Foreign Entities.

2. WHAT ARE THE PRODUCTS AND PRICES?

The satellite data product pricing at Bhoonidhi is implemented based on the guidelines in the Indian Space Policy, 2023. The users are categorized as “Government Entities (GE)” and “Non-Government Entities (NGE)”. Some of the products better than 5m are priced for GE users also as per the Indian Space Policy. All products better than 5m are priced for foreign users. The below list has the details about the products and the corresponding pricing as configured for GE and NGE users.

8. WHAT WILL BE THE DELAY IN PAYMENT AND DATA DELIVERY NOW?

The payment interface is with now with NSIL instead of Bharatkosh. Hence, once the payment is made, the payment details and the PI against which this payment is made is to be mailed to eodata@nsilindia.co.in. There will no change in data delivery timelines.

The new data ordering account created will start with "N" followed by 4 numbers and 2 zeros (Nxxxx00).
