विषय/Subject: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your SANJEEVARAYANA KOTE IRON ORE MINE (M/L No-2289) (Mine Code-30KAR03123) over an area of 42.42 ha in Ballari district of Karnataka State.

महोदय/Sir,

The following provisions of Mineral Conservation and Development Rule, 2017 (MCDR, 2017) were found violated in respect of the above said mine during inspection on 19.12.2024 by Shri Ashish Kumar Behera, AMG and Shri Gopeshjee Parashar, STA (Survey) of this office, in presence of Shri Ragupathy Raj, Mines Manager and other Mine officials.

Rule	Nature of Violations Observed
11(1)	The Mining operations are required to be carried out in accordance with the approved Review of Mining Plan document vide letter no. 279/584/97/BNG dated 13.11.2020. However, during the inspection deviations were observed in mining operation vis-à-vis approved document and are as follows: (i) It was proposed for production of 89970 tonne of Iron Ore & 10796 tonne of mineral rejects during the year 2023-24. However, it was reported the production of 48000 tonne of Iron Ore & no mineral rejects during the year.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty-Five) days** from the date of issue of this letter.
