Sir, The above mine was inspected on 28.08.2025 by the undersigned in the presence of Shri Mohmad Irfan Khan, Geologist in mine and during the inspection, the following provisions of the Mineral Conservation and Development Rules, 2017 were found to be violated. The reply to the violation has been received; however, it has been found unsatisfactory. Therefore, the lessee is requested to submit compliance for the pointed-out violation accordingly.
