C I R C U L A R

One post of Director (Ore Dressing) in the Pay Level-15 (Rs. 1,82,200-2,24,100/-) is vacant in Indian Bureau of Mines under the Ministry of Mines and is to be filled up by Deputation (including Short Term Contract)/Promotion.

02. The Director(Ore Dressing) is the Head of the Ore Dressing Division in the Indian Bureau of Mines. Director(OD) heads three Mineral Processing Laboratories and Pilot Plants which include Modern Mineral Processing Laboratory & Pilot Plant at Nagpur and two Regional Laboratories & Pilot Plants at Ajmer and Bangalore. Responsible to hold the charge of the Mineral Processing Division as a whole and for the planning, direction and management of applied research work of all the three Establishments. The work includes guiding investigations on bench and pilot plant scales on mineral beneficiation for development of process know-how, mineral characterization and beneficiation studies of exploration samples, low grade ores, wastes, rejects and tailings, mineral agglomeration, metallurgy, mineralogical study, chemical analysis of various ores and minerals. Responsible for planning of annual plans/schemes and projects of the Division, monitoring technical consultancy assignments including preparation of Techno-Economic pre-feasibility reports of beneficiation projects, in-plant studies of commercial beneficiation plants and suggesting remedial measures for improvement of plant performance. Responsible for maintenance of internet-based databases including development and operation of Mining Tenement System. Any other duties which may be assigned by the Controller General, IBM.

03. As per the Recruitment Rules for the post of Director (Ore Dressing), the candidate to be considered for appointment by Deputation (including Short Term Contract)/Promotion from the officers under the Central Government, State Government, Union territories, autonomous or statutory organisation, Public Sector Undertakings or University or Recognized Research Institution:-

- (a) (i) holding analogous post on a regular basis in the parent cadre or department; or
(ii)with three years service rendered after appointment to the post on a regular basis in Level -14 in the pay matrix (Rs. 144200-218200) or equivalent in the parent cadre or department; and
- (b) possessing the educational qualifications and experience as below :-
(i) Masters Degree in Ore Dressing or Mineral Processing or Geology or Chemistry or Physics from recognised University or Institution, OR
Bachelor of Engineering or Bachelor of Technology degree in Mineral Engineering or Chemical Engineering or Metallurgy from a recognised University or Institution, and
(ii) Eighteen years experience in a recognised laboratory or plant of Central Government or State Government or Union territories or Public Sector Undertakings or Recognized Research Institution or autonomous or statutory organisation conducting Mineral Beneficiation and/or Mineral Characterization for beneficiation of various ores and minerals.

Note-1: Departmental Chief Ore Dressing Officer in the Level 14 in the pay matrix (Rs. 1,44,200-2,18,200) with three years regular service in the grade and having the educational qualifications and experience prescribed for considering appointment on deputation basis shall be considered alongwith outsiders. If the departmental candidate is selected for appointment to the post, it shall be treated as having been filled by promotion.

Note-2:- The Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed five years.

Note-3:- The maximum age-limit for appointment by deputation shall be not exceeding fifty eight years as on the closing of receipt of application.

04. The deputation period will be initially for 03 years and will be considered for further extension on the basis of requirement of this department and NOC from the parent department. However, the officer may also consider for pre-mature revision to the parent cadre by serving 03 months advance notice to the parent department as well as to the officer in terms of provisions contained under DOPT OM No.6/8/2009-Estt. (Pay II) dated 17.06.2010.

05. Application containing the bio-data (in triplicate) of the official who fulfills the above as on the closing date may be sent through proper channel addressed to **The Head of Office (Hq), 4th Floor, Indian Bureau of Mines, Indira Bhavan, Civil Lines, Nagpur - 440 001** in the enclosed bio-data proforma (Annexure-I) within 60 days from the date of publication of advertisement in the Employment News alongwith the up-to-date Confidential Reports/Dossiers for the preceding 5 years, Integrity Certificate, Vigilance Clearance and No penalty certificate for preceding 10 years of the official concerned. Applications received after the closing date will not be entertained. Also, advance copies of applications or not accompanied with all the above certificates/enclosures are liable to be rejected.

06. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
